My work

My philosophy of practice and facilitation is based on humanistic psychology and, specifically, the person-centred approach and transactional analysis. Working with groups, teams and organisations, I am interested in facilitating everyone to express their voice, in group dynamics and processes, and in helping to build genuine and co-operative working, learning and thinking environments.

As a psychotherapist I had a private/independent practice since 1987 – in London, UK (1987-1992), in Sheffield, UK (1992-2009), and, since 2009 have maintained an overseas practice as a psychotherapist (see footnote 2, p. 1 above). Now, as a health care provider and transactional analyst, I have a small private practice in West Auckland. I have worked with children and young people as well as with adult clients, short-term as well as long-term, and have run several psychotherapy groups for a number of years.

I have been working as a clinical supervisor since 1983, and have experience of working individually and in groups with a variety of professionals. For the past six years, I have developed supervision by Skype. I have supervised practitioners who, in turn, work with individual clients and with groups, including children and young people as well as adults. I supervise members of the NZAP and the NZAC, an ACC Approved Counsellor, and two DAPAANZ registered practitioners I also run groups for the continuing professional development of psychotherapists and counsellors, and for therapists preparing for qualifying examinations as clinicians, trainers and supervisors.

As an academic supervisor I have supervised fifteen master's dissertations to successful completion. Currently, I am the principal supervisor of three doctorial students, and the second supervisor of one doctoral student and one master's student.

As an examiner I have examined candidates' written work – case studies at M (Masters) level – and have been on the exam board/panel for candidates viva voce exams at all levels – from Diploma (level 7), and Masters (level 9) and to post-qualifying exams of teaching and supervising therapists and educators.
